THE TELECOMMUNICATION ORDER (4 of 2004)

In exercise of the powers conferred upon it under the Information & Communication Technologies Act 2001, the Information & Communication Technologies Authority (hereinafter referred to as the **Authority**) hereby issues the following directive in respect of tariff for International Direct Dialing (IDD) Calls.

1. Short title, extent and commencement:

- (i) This Directive shall be referred to as “The Telecommunication Order 4 of 2004”.
- (ii) The Telecommunication Order (4 of 2004) shall come into force with immediate effect.

2. Determination on Tariff for IDD Calls

- (i) The determination of the Authority on tariff for IDD Calls is specified in Schedule I thereto.
- (ii) The tariff set out in Schedule I shall be implemented by International Long Distance (ILD) Operators.

- (i) Pulse rate shall be on per second basis after the first 30 seconds.
- (ii) Off peak timings shall be as follows:-

- (iii) The Off Peak tariff may be applied for pre paid services.
