The Information and Communication Technologies Authority, in exercise of the powers conferred upon it by Section 24 of the Information and Communication Technologies Act 2001 as amended and of all other powers exercisable by this Authority for that purpose, hereby grants an

**AERONAUTICAL BASE STATION (ERP EQUAL TO OR MORE THAN 5W
BUT LESS THAN 100W) LICENCE – RA02 Licence [as per the Information
and Communication Technologies (Amendment of Schedule) Regulations 2003]**

to

AERONAUTICAL BASE STATION (ERP EQUAL TO OR MORE THAN 5W BUT LESS THAN 100W) LICENCE

Terms and Conditions

1. The licence is issued to “XXXXXX”, hereinafter referred to as “the Licensee”.
2. The Licence is valid for a period of one year, with effect from **XX XXXX 2004**.
3. An annual licence fee amounting to Rs. 2,500/-, is payable to the Authority. The licensee shall effect payment with respect to the annual fee at least 15 days prior to its anniversary every year.
4. A surcharge of 10% on the licence fee which is due to be payable, in the event the licence fee is not paid at least 15 days before the anniversary of the licence.
5. Where the licence fee remains unpaid for a period of 90 days as from the date the licence fee is due, the Licence may be revoked in accordance with the Act.
6. The Aeronautical Base Station shall operate on the simplex frequency ‘**xxxx MHz**’ assigned to the Licensee, on a non-exclusive basis. No other frequency should be installed or caused to be programmed on the Aeronautical Base Station owned and operated by the Licensee.
7. The Licensee shall operate the Aeronautical Base Station to communicate with aircrafts **only**.
8. The maximum effective radiated power (ERP) of the Aeronautical Base Station shall be limited at all times to **xxW**.
9. The Licensee, shall not modify the Aeronautical Base Station or cause it to be modified without the prior approval of this Authority.
10. The Aeronautical Base Station shall be operated only at **xxxx** and within a range of **XXXXXXXXXXXXXXXXXXXX** and shall not be transferred to be used at any other location.
11. The Licensee shall ensure that the Aeronautical Base Station is operated in such a manner as not to cause direct or indirect harmful interference with any other telecommunication service or any other apparatus or device(s) lawfully operated in or outside Mauritius and shall also take all necessary measures at its own cost to stop such harmful interference as and when they may occur.
12. The Authority reserves the right to withdraw any frequency and may require the Licensee to cease using any previously assigned frequency if in the opinion of the Authority, the

Licensee is not making efficient use of that frequency or for any other reason, and to use such new frequency as the Authority may designate, without prejudice to the Authority.

13. The loss of any of the radio equipment of the Aeronautical Base Station shall be immediately reported to the police and to this Authority. The resale or disposal of the Aeronautical Base Station shall be done with prior consent in writing of this Authority.
14. At all material times, the Licensee shall ensure that only persons authorised by the licensee have access and are able to operate the Aeronautical Base Station. The licensee shall ensure further that persons operating the Aeronautical Base Station or having access to it, observe the conditions of this licence and shall assume all liabilities arising out of such use and operation of the Aeronautical Base Station.
15. The Licensee shall ensure that persons operating the Aeronautical Base Station observe the above conditions and the provisions of the Information and Communication Technologies Act 2001 (as amended), and that they do not operate the Aeronautical Base Station for any unlawful purpose.
16. The Licensee shall make the Aeronautical Base Station available for inspection at all reasonable times by the staff of this Authority
17. The Authority reserves the right to:-
 - a. not automatically renewing the licence after its expiry;
 - b. to revoke the licence if the Authority considers that the licensee is not operating under this licence, to its satisfaction, as specified in the Information and Communication Technologies Act of 2001 (as amended);
 - c. to impose additional restrictions/obligations concerning the operation of this licence as and when required.
18. The ICT Authority shall not be liable in any manner whatsoever for any damage and/or prejudice arising by virtue of this licence.
19. The licensee shall not operate any Aeronautical Base Station without there being in force a valid and enforceable licence.
20. The ICT Authority reserves the right to modify this Licence as may be required for the safeguard of public interest or national security.
21. This licence is not transferable.
