ADDENDUM NO.1

**Amendment to bidding document for Enhancing Internet Connectivity for
Agalega Islands under the Universal Service Fund (USF) - Phase III**

With reference to the procurement exercise for “*Enhancing Internet Connectivity for Agalega Islands under the Universal Service Fund (USF) - Phase III*”, the ICT Authority wishes to inform bidders that:

- a) The date for submission of queries by bidders is being extended from *Monday, 01 December 2025* to ***Monday, 08 December 2025***.
- b) The deadline for submission of bids is being extended from *Friday, 09 January 2026* to ***Monday, 19 January 2026 by 13.00 hrs.***
- c) The date for bid opening shall be on ***Monday, 19 January 2026 by 13.15 hrs.***
- d) The date for the bid validity is being extended from *Monday, 13 April 2026* to ***Thursday, 23 April 2026.***

Consequently, the below detailed amendment is being brought to the following sections of the bidding document:

- i. At page 27, ITB 8.1(b) to be read as follows:

“Bidders are required to submit all their queries to The Chairperson, Departmental Bid Committee by email (ctc@icta.mu) by latest Monday, 08 December 2025. The ICT Authority will reply to all queries by Monday, 15 December 2025, whereby replies and clarifications issued, if any, will be available on the Authority’s website: www.icta.mu.”

- ii. At page 29 of the bidding document, ITB 21.1 to be read as follows:

"The deadline for submission of bids:

Bids should be deposited in the Tender Box located at Reception of the ICT Authority, Level 9, The Celicourt, 6, Sir Celicourt Antelme Street, Port Louis 11302, not later than Monday, 19 January 2026 by 13.00 hrs. Bids received by e-mail will not be considered. Late submissions will be rejected."

iii. At page 29 of the bidding document, ITB 24.1 to be read as follows:

"Bids will be opened Monday, 19 January 2026 by 13.15 hrs, at the ICT Authority, in the Board Room, Level 9, The Celicourt Building."

iv. At page 28 of the bidding document, ITB 16.1 to be read as follows:

"The period of Bid validity shall be 95 days after the deadline for Bid submission, the submission date being counted as day one of the validity period and shall be valid up to Thursday, 23 April 2026 (95 days as from closing date)."

These amendments should be taken into consideration upon submission of bid and shall form an integral part of the bidding document, as amended.
