

# Information and Communication Technologies (Licensing and Fees) Regulations 2003

GN 97/2003

## THE INFORMATION AND COMMUNICATION TECHNOLOGIES ACT 2001

### Regulations made by the Minister, after consultation with the Board of the Authority, under section 48 of the Information and Communication Technologies Act 2001

1. These Regulations may be cited as the **Information and Communication Technologies (Licensing and Fees) Regulations 2003**.

2. In these regulations -

"Act" means the Information and Communication Technologies Act 2001;

"anniversary date" means the annual anniversary of the effective date of a licence;

"annual fee" means the fee mentioned in the fourth column of the Schedule and payable annually in respect of a licence;

"application fee" means the fee payable to the Authority for the processing of an application for a licence;

"effective date" means the commencement date of a licence;

"initial fee" means a fee mentioned in the third column of the Schedule and payable to the Authority upon the grant of a licence;

"gross turnover" means —

(a) the retail and wholesale revenue generated from the provision of information and communication services under a licence held by a public operator before any deduction for expenses, taxes, discounts, returns and offsets of any kind; but

(b) does not include revenue from taxes and charges collected for, and on behalf of, the Government;

"licensee financial year" means the financial year of a licensee;

"retail revenue" means revenue generated by a public operator from the provision of information and communication services to final end-users;

"wholesale revenue" means revenue generated by a public operator from the provision of access to its

facilities and services by a person for the purpose of providing information and communication services and revenue from interconnection.

3. Any person who wishes to operate an information and communication network or provides an information and communication service shall, notwithstanding any other enactment, apply for the appropriate licence specified in the Act and reproduced in the Schedule to these regulations.
4. A licence issued by the Authority shall be of such duration as shall be specified in the licence.
5. A non-refundable application fee of Rs 2,000 shall be paid to the Authority upon application for a commercial or private network licence specified in the Schedule.
6. (1) Subject to paragraphs (2), (3) and (4), where the Authority grants a licence, it shall issue such licence upon payment by the applicant of the initial fee and for a Category 1 licence where the prescribed flat annual licence fee exceeds 500,000 rupees, upon furnishing a bank guarantee of 500,000 rupees for a minimum period of 3 years and renewable throughout the duration of the licence.  
  
(2) Where, upon an application for a licence, the Authority grants the application, the applicant shall, not later than 3 months from the date on which the application was granted, take out a licence subject matter of the application.  
  
(3) Where an applicant fails to comply with paragraph (2), the Authority may rescind its decision, unless the applicant has, on or before the expiry of the period of 3 months, applied to the Authority for an extension of time by giving reasonable grounds for his inability to operate the information and communication network or to provide the information and communication service within the specified period.  
  
(4) Where the Authority grants an application for extension of time under paragraph (2), the applicant shall operate the information and communication network or provide the information and communication service within a period fixed by the Authority but not exceeding 3 months, failing which the Authority shall rescind its decision and no further request for an extension shall be entertained.

7. (1) Subject to regulation 10, every licensee shall pay to the Authority an annual fee on the date of issue of the licence and thereafter not later than 15 days before the anniversary date of the licence.

- (2) Where a licensee has paid the annual fee prior to the coming into operation of these regulations, he shall, subject to regulation 10: pay the appropriate annual fee specified in the Schedule not later than 15 days before the anniversary of the licence.
- (3) Where a new licence has been issued in replacement of a licence which has been surrendered to the Authority pursuant to section 51 of the Act, the anniversary date of the new licence shall be deemed to be the anniversary date of the surrendered licence.
8. The annual fee in respect of SPL.10 to SPL.39 type licences specified in the Schedule shall, where the licensee is assigned the exclusive use of the frequency band, be 3 times the corresponding annual fee specified for that licence.
9. (1) Subject to paragraph (2), where the Authority has granted a licence for a period of not more than 3 months, the fee payable in respect of that licence shall be half the annual fee.
- (2) Where the Authority grants a RA25 (Radio Amateur Visitor's) licence for a period of not more than 6 months, the licensee shall be exempt from payment of the annual fee.
10. Where an annual fee is in excess of Rs 100,000 rupees, the Authority may authorise that the fee be paid in 12 monthly equal instalments, the first instalment being payable upon issue of the licence and each remaining instalment being payable at latest on the first day of each subsequent month.
11. Where a licensee fails to pay the annual fee, or any instalment, as the case may be, within the time specified in these regulations, he shall in addition to the amount due, pay a surcharge of 10 percent.
12. (1) An application for the renewal of a licence shall -
- (a) in respect of a Category I licence, be made by the holder of the licence at least 6 months before its expiry; or
- (b) in respect of a Category 3 licence, be made by the holder of the licence at least 2 months before its expiry.
- (2) The application under paragraph (1) shall be accompanied by such information as the Authority may require.
- (3) No application for the renewal of a licence shall be entertained where the holder of the licence fails to make the application for renewal within the delay specified in paragraph (1).

13. The licensee shall -

- (1) refer for determination by the Authority, any question of interpretation arising under his licence;
- (2) be bound by any determination made by the Authority pursuant to a reference made under paragraph (a), until such time as the Tribunal or a court of competent jurisdiction decides otherwise.

**14.** Where a licensee provides a telecommunications service *or* operates a telecommunication network, he shall within 14 days *of* the start *of* the provision *or* operation, notify the Authority in writing.

**15.** Where the licensee terminates the provision *of* a telecommunication service *or* the operation *of* a network, he shall within 28 days *of* the termination, notify the Authority *of* the termination in writing.

**15A.** (1) In this regulation -

"corresponding licence" means an RA16A licence;

"licensee" means the holder of an original licence;

"original licence" means an RA16A licence issued prior to the coming into operation of these regulations.

(2) (a) Every licensee shall, within the timeframe to be determined by the Authority, but not later than 6 months after the coming into operation of these regulations, surrender his original licence to the Authority for the issue of a corresponding licence.

(b) Where a licensee surrenders his original licence pursuant to subparagraph (a), the Authority shall, where all requirements are met under the Act and these regulations, issue him with the corresponding licence on such terms and conditions as it may determine.

(c) Where a licensee who is issued with a corresponding licence under this paragraph has, prior to the coming into operation of these regulations, already paid his annual fee for the current year, he shall, for the forthcoming year onwards, pay the new annual fees not later than 15 days before the anniversary date of the corresponding licence.

(3) (a) Notwithstanding paragraph (2)(a), where an original licence is, on the coming into operation of these regulations, due for renewal, the licensee shall, within the delay for renewal, apply for renewal of the original licence.

(b) Where an application for the renewal of an original licence is made pursuant to subparagraph (a), the Authority shall, where all requirements are met under the Act and these regulations, issue the corresponding licence on payment of the appropriate fee and on such terms and conditions as it may determine.

(c) Where, pursuant to subparagraph (a), the licensee fails to renew his original licence, the original licence shall lapse on the expiry date and no application for renewal of the original licence shall be entertained.

(4) (a) Where, prior to the coming into operation of these regulations, an application for the renewal of an original licence is made, the original licence shall, on the coming into operation of these regulations, be deemed to have been surrendered for the issue of a corresponding licence.

(b) Where an original licence is deemed to have been surrendered pursuant to subparagraph (a), the

Authority shall, where all requirements are met under the Act and these regulations, issue the corresponding licence on payment of the appropriate fee and on such terms and conditions as it may determine.

(5) A licensee referred to in this regulation shall furnish to the Authority such additional information as it may require concerning his original licence for the purpose of determining the corresponding licence to be issued.

(6) (a) An original licence shall remain valid until its corresponding licence is issued.

(b) A corresponding licence shall retain both the anniversary date and validity of its original licence.

**15B.** An RAI6A licence shall be issued to the following persons -

(a) Government entities responsible for national security and disaster management or such other entity as may be recommended by the Ministry responsible for the subject of defence and home affairs;

(b) diplomatic missions, consulates-general, consulates and regional or international organisation based in Mauritius for official use or such other entity as may be recommended by the Ministry responsible for the subject of foreign affairs;

(c) local or multinational corporations operating in Mauritius, duly recommended by the Ministry responsible for the subject of defence and home affairs, and having as an internal policy requirement to hold a Mobile Transceiver Terminal (in a Mobile Satellite Service) strictly for preparedness for disasters of all kinds, emergency usage and ensuring business continuity and recovery plan;

(d) any other person duly recommended by the Ministry responsible for the subject of defence and home affairs.

**15C.** Notwithstanding regulation 15B, the possession and use of devices in a GMPCS system on board an aircraft or a ship, registered in Mauritius, for the purpose of life safety, search and rescue and accident investigation, shall be authorised under the respective aircraft station and ship station licence and the list thereof shall be communicated regularly to the Ministry responsible for the subject of Defence & Home Affairs and External Communications.

**15D.** (1) Any person who wishes to obtain a licence to operate as a Mobile Number Portability (MNP) Service Provider shall, upon invitation by the Authority, make a written application in such form and manner as the Authority may approve.

(2) Any new International Long Distance (ILD) licensee or Mobile Number Portability (MNP) service provider shall, prior to being issued with his appropriate licence -

(a) pay, for his first year of operation, a flat annual licence fee of 100,000 rupees; and

(b) furnish a bank guarantee of 500,000 rupees for a minimum period of 3 years and renewable throughout the duration of the licence.

(3) Notwithstanding paragraph (2)(a), where the annual licence fee becomes due under regulation 7(1), any ILD licensee or MNP service provider shall pay to the Authority the licence fees in accordance with the Schedule, not later than 15 days before the anniversary date of the licence.

(4) Any ILD licensee or MNP service provider shall, for the purpose of these regulations, furnish to the Authority a true and certified copy of its audited annual gross turnover relating to his business operations under his licence for the penultimate licensee financial year, as applicable, not later than 90 days before the anniversary date of the licence, failing which the prescribed maximum licence fee shall become due and demandable.

(5) The Authority shall compute the annual licence fee payable based on the information furnished pursuant to paragraph (4).
