## **EXPRESSION OF INTEREST**

## **AUTOMATED SPECTRUM MANAGEMENT SOFTWARE**

The Information and Communication Technologies Authority (ICTA) is a body corporate established under Section 4 of the ICT Act, with objects and functions enshrined under Section 16 and 18 respectively of the ICT Act 2001, as amended.

Under section 18(p) of the ICT Act, the Authority has the statutory duty to allocate frequencies and manage, review, and where appropriate, reorganise the frequency spectrum in the Republic of Mauritius. In order to undertake this duty efficiently, the Authority requires appropriate software tools.

The ICTA hereby invites well established and suitably experienced firms specialised in Automated Spectrum Management Software (ASMS) to express their interest, either directly or through a local agent, in order to be enlisted in the ICTA's supplier database.

Submissions from interested parties shall meet the scope of work and other terms and conditions as set out herein.

#### Scope of Work

To propose an ASMS that would support the ICTA in its spectrum management duties under the law, including national spectrum planning as well as international coordination. The ASMS should be able to interact with spectrum monitoring software as well as with Licence management databases.

Any proposed ASMS shall be in compliance with the following ITU-R Recommendations: -

- 1. ITU-R SM 1370;
- 2. ITU-R SM.1537, and,
- 3. ITU-R SM.1050

### Other terms and conditions

- 1. In order to determine the capability and experience of firms seeking to be short listed, the ICTA request for the following:
  - a) A profile of the company, its organisation and staffing;
  - b) In the case of associations between two or more firms, or any local agent, the name, address and profile of the participating firm, and nature of the association such as joint venture, subcontractor or agent.
  - c) Identification of any lead firm;
  - d) Details of experience or similar assignments undertaken in the previous five years, including their locations;
  - e) The focus on the firms' role in similar assignments in the region or elsewhere;
- 2. Indicative budgetary prices of the core software along with its related optional modules and services shall be provided.
- 3. This EOI should not be construed as an obligation to any award of contract.
- 4. Short-listed parties may be invited to participate in a bidding exercise at a later date to be determined by the ICTA.
