

**ADDENDUM No.3**

**Subject: Addendum No.3 for Procurement Exercise ‘Free Wi-Fi Service in Mauritius and Rodrigues’**

The ICT Authority is hereby issuing the following **Addendum No.3** in connection with the procurement exercise “***Free Wi-Fi Service in Mauritius and Rodrigues***”, Ref **CPB/05/2021**, which is available on the websites publicprocurement.govmu.org and www.icta.mu.

This Addendum No.3, shall form an integral part of the bidding document, as amended and be taken into consideration upon the submission of a bid.

- i. At pages 32 – 34 of the bidding document, the Bid Submission Form is being deleted and replaced by the **New Bid Submission Form** as provided at Annex to this Addendum.
- ii. Item No.8 under Section IV ‘Evaluation Criteria’ at page 41 of the bidding document is being deleted.
- iii. A new paragraph 13 at page 48 under Scope of Service and Performance Specifications, under Statement of Work is being inserted and shall read as follows:

**13.** *‘At the time of commissioning of each site, the successful bidder has to provide a detailed coverage heat map of all regions it would cover along with the specific equipment it would install for all sites at Annex A for the provision of the service. Bidder to provide details on how the WAPs shall be deployed to provide maximum coverage whilst achieving an RSSI of -67 dBm or better and SNR of  $\geq 20$  dB whereby same will be measured during commissioning phase with a calibrated Wi-Fi tester to be provided by the successful bidder.’*

- iv. Item No.15 of Annex B, at Page 103 of the bidding document is being amended to now read as follows:

*‘At the time of commissioning of each site, the successful bidder has to provide a detailed coverage heat map of all regions it would cover along with the specific equipment it would install for all sites at Annex A for the provision of the service. Bidder to provide details on how the WAPs shall be deployed to provide maximum coverage whilst achieving an RSSI of -67 dBm or better and SNR of  $\geq 20$  dB whereby same will be measured during commissioning phase with a calibrated Wi-Fi tester to be provided by the successful bidder.’*

- (a) We have examined and have no reservations to the Bidding Documents, including Addenda issued in accordance with Instructions to Bidders (ITB) Clause 11;

- (d) Our bid shall be valid for a period of 120 days from the date fixed for the bid submission deadline in accordance with the Bidding Documents, and it shall remain binding upon us and may be accepted at any time before the expiration of that period. A bid security for the amount of Mauritian Rupees (MUR) 5,000,000 and valid up to 04 February 2022 is also enclosed;
- (e) Our total bid price, including the monthly bid price on region-wise basis, shall be binding for additional extension of the duration of the project, by a further of six (6) months, if any;
- (f) If our bid is accepted, we commit to obtain a Performance Security in accordance with the Bidding Document;
- (g) We, including any subcontractors or suppliers for any part of the contract, do not have any conflict of interest in accordance with ITB 6;
- (h) We are not participating, as a Bidder in more than one bid in this bidding process;
- (i) Our firm, its affiliates or subsidiaries, including any Subcontractors or Suppliers for any part of the contract, has not been declared ineligible under the laws of Mauritius;
- (j) We are not a government owned entity / We are a government owned entity but meet the requirements of ITB 4.5;<sup>1</sup>
- (k) We understand that this bid, together with your Letter of Acceptance, shall constitute a binding contract between us, until a formal contract is prepared and executed;
- (l) We have taken steps to ensure that no person acting for us or on our behalf will engage in any type of fraud and corruption as per the principles described hereunder, during the bidding process and contract execution:
  - i. We shall not, directly or through any other person or firm, offer, promise or give to any of the Public Body's employees involved in the bidding process or the execution of the contract or to any third person any material or immaterial benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
  - ii. We shall not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelisation in the bidding process.
  - iii. We shall not use falsified documents, erroneous data or deliberately not disclose requested facts to obtain a benefit in a procurement proceeding.

We understand that transgression of the above is a serious offence and appropriate actions will be taken against such bidders.
